Bills displayed via internet account are due and payable as set forth above whether or not separate bills are transmitted. In the event of Customer payment default, Alpine shall be entitled to collect from Customer all costs of collection, including attorneys' fees, and interest at the rate of 1.5% per month, both before and after judgment. Payments that identify a particular invoice or project will be applied to that particular invoice or project. Absent such identification, or in the event of payment default, Alpine reserves the right in its sole and absolute discretion (subject to applicable law) to apply payments to any unpaid account of Customer as determined by Alpine.
